West Street property:

No new news

Mayor Hennings stated that we did not re-appoint our current attorney at the reorganizational meeting; Village is currently looking for another attorney. William Wilder stated that Michelle Broadbent had interest in this position.

Trustee Woods asked if there was any interest in repairing the pot holes around the village. Stated that the cold patch won't work that we would need to cut the road and do it the correct way. Mayor Hennings asked if Herm Harris and Trustee Woods would work on this together, getting a list of everyplace that needed to be repaired. They agreed to take it away.

Public comment to start @ 7:11 PM not to exceed 30 minutes

Mark Oakley asked if there was any new news on the wall at Storm Kovac Property on Main St. Mayor Hennings stated that there is not. Storm Kovac stated the he bought the house thinking that it was sound and the previous owner had an engineer sign off on it and never was present, and that he thinks that the Village should hold responsibility for it and wanted to seek council. Trustee Roberts stated that the previous owner may not have done the right thing but the Village did not know about it at the time. Mayor Hennings stated that the code officer is not an engineer and that an engineer placed his stamp on it, and that she would talk to George Farley and Audrey Dunning and that Storm Kovac should proceed as he see fit. Discussion ensued.

William Wilder asked about building permits and who he would ask if one was given. Mayor Hennings stated that he could ask George Farley or foil it from the village clerk. William Stated that the Newport Marketplace built a roof over a current roof over the back deck he then asked George if any permits had been issued to the marketplace in the past. George said he thought a couple of different permits had been issued. Discussion ensued.

Craig Felhaber stated that the engineer of the Main Street property (being he is licensed) is subject to a review of the work done and this matter can be brought before the state board. He stated that George Farley isn't an engineer but can ask questions on why you think its ok. Discussion ensued.

Craig Felhaber stated that the West Street property started a year ago and he keeps hearing the lawyer is working on it and we're still working on it. He said that if the village is looking for a new lawyer that is should be posted in the paper

for this. He also stated that the pot hole issues need to go out to bid, should hold a pre bid conference so that the contractors know what areas need to be fixed and have a pre bid packet. Discussion ensued.

William Wilder stated that he wouldn't be surprised if the West Street property had a for sale sign on it soon. Craig Felhaber stated that the village should place a lien on it. Discussion ensued.

The vouchers were reviewed and signed and the bank statements and balance sheets were reviewed.
