Craig Felhaber asked about the West St. demo, Wanted to know if the project is complete, George Farley Stated that the project is complete. Mayor Hennings stated that the final bill was for \$34,800.00 with a \$200.00 offset for the stone (he gave us the credit). Wanted to know how we were going to re coupe the funds, Audrey stated that we would have to wait until January after the tax rolls are certified. Craig stated that the public needs to know how we are going to get the funds back.

Craig Felhaber wanted to know if we are still looking into a new bobcat and stated that we should have a snow blower attachment; Mayor Hennings stated that we already have one with our current Bobcat. Herm Harris stated that Warner's Sales came to look at the Bobcat 2 weeks ago. Herm stated that he doesn't like to use the blower as much due to the fact that he can't remove the snow from the fire hydrants as he is doing the sidewalks and that it burns  $2.5 - 3 \, x$ 's as much fuel.

William Wilder asked if there were any options for the West St demo then to put on tax rolls, He also stated that he is representing the family and want to know what options are out there for them. Mayor Hennings stated that we need to follow NYS laws so we can move forward. William asked if they can't be put on tax rolls should we know at January meeting, Mayor Hennings stated that we should know something then and that as previously stated we are looking at options.

Craig Felhaber asked about replacing the floors in the firehouse and if we knew any more on that. Mayor Hennings stated that Dave Jones from the Fire Dept. is looking into that for us. Craig asked when anyone else knows that this project is going on. Mayor Hennings stated that we are following the procurement policy and getting additional quotes but a bid process is not necessary.

Craig Felhaber asked about getting a new phone for Herm Harris and wanted to know where we at with that. Mayor Hennings stated that Herm received a new phone several months ago and that Verizon replaced the phone for free.

Trustee Roberts asked the Fire Dept. about the storage room and the possibility of getting rid of the old computers to make some room for the village to store some more stuff in there. Tim McEvoy stated that cleaning out the storage room this week was a project for him. Trustee Roberts stated that we are just looking for more room for file cabinets for the village.

Motion made by Mayor Hennings, seconded by Trustee Roberts to close the meeting @ 7:36PM.
