Malcolm Harris asked about work done around 1st Avenue and Harris Avenue; questions were posed around work not completed by Water Project contractors, discussion ensued.

Dick Foster asked question regarding the certificate of inspection for the firehouse smoke/fire alarms. Was told boiler is done last year and completed yearly but smoke/fire would have to be

looked into. Asked about special meeting times and what the parameters around scheduling meetings were. Mayor Hennings stated that meetings are scheduled according the Open Meeting Laws and notice is given to the extent practicable. Notice is sent to the Village paper as soon as possible, posted on the Village posting board as well as the Village website.

William Wilder asked about what was buried in the old reservoir. Mayor Hennings said the Village had been asked about this and that she worked with the Dept. of Health on this last year.

Heidi Worden asked questions regarding planning board schedule and fire prevention code. Short discussion ensued. George said that he would contact the county to see who owns the property, Mayor Hennings asked George to follow up on this.

Dick Foster asked what the yellow shed at the playground was for. Mayor Hennings said that there is equipment stored in there and it belonged to Little League and they were asked to move it.
