Fire Dept.:

Mayor Hennings told us the new officers were sworn in at the annual dinner on January 11, 2014, new chief is Mark Farrell.

Recreation / ski club:

The ski club had to cancel on January 2 due to weather. On January 9th they had 16 people go and on January 16th they had 21 people go. The letters are ready to go out to the neighboring communities for donations.

Water project:

Bids were due on December 18, 2013 at the firehouse. Mayor Hennings said that the numbers that came in were pleasing.

4 Construction bids:

- 1. Water source / Water Main Improvements: 9 bids were received. The Low Bid came from V&B Underground Utilities from Rochester NY in the amount of \$689,376.75. Jack Dodson said he checked the references and sees in reason not to give them the bid.
- 2. Filtration Building: 6 bids were received. The low bid came from Deschene for \$350,000.00, Dodson examined bid and found several informalities including incorrect bid bond form and no statement of survey intent and the low bid amount. It was Dodson opinion that the bid from Deschene not be accepted by the village. The 2nd lowest bid came from Stephen Miller General Contractor from Mayfield, NY. The bid amount was for \$509,800.00 and no informalities were found in their bid. It is the option of Dodson to accept the bid from Stephen Miller General Contractors.
- 3. Electrical /Instruments and control Improvements: 4 bids were received. The low bid came from S.C. Spencer Electric of Constableville, NY in the amount of \$196,500.00. It is the opinion of Dodson to award this bid to S.C. Spencer Electric.
- 4. 294,000 gallon bolted steel water Storage Tank: 6 bids were received. The low bid came from Jersen Construction Group LLC from Waterford, NY for \$695,270.00. There were some informality in the bid but they were contacted and Dodson was satisfied with their bid as submitted. Dodson see no reason not to award this bid to Jersen Construction Group LLC.

Jack said that award letter will be sent to the appropriate parties to be signed. After returned and reviewed copies will be sent village attorney to be reviewed by the Village attorney. After will set up a pre – construction meeting for the setup of the timeline of the project.

Discussion took place about local cancer cases and local testing places to take water samples to.
