Awarding bid for demolition / removal project for Hans Flaatrud Property Tax Map 094.46-1.25 and 094.46-1.26:

Mayor Hennings said that the village board has reviewed all the bids presented to the Village: Reviewed the lowest 3 bids: the board removed the bid from Main St metals because of lack or references or work history. The next 2 came from Ritter & Paratore for \$35,890.00 and TJ Allen for \$35,900.00 difference between the 2 companies were \$10.00. Discussion had said the Ritter & Paratore has experience in the field with every person o site. 40 hours of asbestos certificate, an insurance and workers Comp., Air Monitor \$500.00 - \$700.00 per day

Bill Wilder asked about Borden's building, Mayor stated that on the Codes/Zoning Officer had contact with owner and to date nothing had been received by the ZBA nor Planning Board. Discussion ensued

Tammy Gornishek asked about the East Street project in regards to the flood damage and water runoff. Mayor Hennings stated that we are actively seeking bids for a temporary fix as we continue to look to secure grants for funding. To date, we have 1 bid. Discussion ensued.

Craig Fehlhaber asked bout about the correspondences and decisions regarding the Flaatrud property. Mayor Hennings stated that the building had been condemned and has begun falling down and apart this past winter. Discussion ensued.

The vouchers were reviewed and signed and the bank statements and balance sheets were reviewed.
