Craig Felhaber asked who owned the building on Bridge St and as a tax payer he had concerns and doesn't think that we should have to find another place for our offices and asked how the fire equipment would work if the district goes though. Mayor Hennings stated that the fire district went through the district would pay the lease to the village. Also stated that any taxes raised and reserve will go with the fire dept.

Craig Felhaber asked about there being no village attorney and if board has looked at this and if we have had any interests into the position. Mayor Hennings stated that we have capped current lawyer Audrey Dunning and are sending her a signed letter, the cap was set at \$6,000.00 and we except it back by the end of the month.

Mayor Hennings stated that last year with the summer youth program we had a few spots that they held out last minutes to fill. The village ended up hiring a couple of kids on their own and that the village always hires the director.
