Insurance review:

A couple of things that he came back with that we need to look into fixing, the boiler at the library, tops for the playground fence, need to have something to protect and also shared services with the Town for things like plowing. The insurance guy from Mang is also the mayor for Gloversville and was going to look into how they gifted the library building to the library and see if this is something that our Village would like to look into to.

Water project update:

There is 4ft left to fill in the tank. Jack Dodson suggested that we hire a leak detection agency, this would cost anywhere from \$5000.00-\$25000.00, we have money left in the water project fund that could be used for this. They would come out at night when the water usage is low, some things they could find is old pipes or pipes that ae left uncapped. V&B will be onsite starting tomorrow and will be there for the next 4-5 weeks to finish the landscaping and also to loop in the pipes.

She stated that she was under the understanding that the neighbor could not use the Bridge pieces that he had been using. She also said that although he hadn't contacted the Village he had done some work to the retaining wall. Discussion between the board and the Oakley's ensued. Mr. Farley said that he would look into the issue and would contact the Village attorney to discuss how to proceed. He would also like a second opinion from a professional engineer. A discussion continued.

Heidi Worden asked who was financially responsible for fixing the water lines. Mayor Hennings said that it depended on where the leak was located. She also asked if she could get a copy of the transfers done. Mayor Hennings stated that they would be placed in the minutes. She asked about an email she had sent asking for some information. Mayor Hennings said she would send her a copy of the letter. Heidi asked if anyone looks at the property taxes after permits are issued. Mayor Hennings said the Village uses the Town assessment.

Mayor Hennings asked Mr. Felhaber if he had sent any information regarding his water lines. He said that his engineers were working on it and that he had not sent anything to the Village.
