Village of Newport Regular Meeting

October 21, 2024

The regular meeting of the Village of Newport was called to order on October 21, 2024 at 7:01 p.m. by Mayor Butler with the following members present:

Pledge of Allegiance

A motion was made by Trustee Woods to accept the September Minutes; seconded by Trustee Roberts and unanimously approved.

Public Comments: There was a continuation of the discussion from the 6:30 p.m. Public Hearing regarding new parking regulations. Residents on School Street are concerned about current water run-off. Some residents requested that curbs and sidewalks be removed as they feel the curbs are now much farther away from the sidewalks than they had been prior to their replacement. There was a discussion about whether or not to make the street one-way or have no parking on the street. Bruce Moody offered to change the corner by his business at his own expense, offering pictures of the current layout (attached). As he owns property by the old elementary school, S. McEvoy requested something in writing from the Village releasing him from liability if parking is allowed there.

Mayor's Report:

- 1. Mayor Butler reported that there are several grants totaling close to \$500,000 to go towards the demolition of the old elementary school.
- 2. Mayor Butler advised that there will be a Public Hearing held on November 14, 2024 at the Community Hall/Masonic Temple.

Trustee Roberts proposed; 2nd by Trustee Woods. Unanimously passed.

A brief discussion was held concerning a better form of communication between the Village Board and the citizens.

Trustee Woods requested the General Meeting be adjourned, which was seconded by Trustee Robert and unanimously passed. The General Meeting adjourned at 8:06 p.m.
