## Mayor's Report:

- 1. Mayor Butler reported that the Village Christmas Party held on Sunday, December 15, 2024 at the Community Center was not a huge success, with only about ten children attending. However, all children left with a prize, and those who were there enjoyed the day. It was suggested that the Village gain more of a presence with its residents, perhaps via Facebook, *The Rome Sentinel*, or other means of advertising events such as this.
